4. For short-listed candidates' interview will be held **virtually via Zoom Platform on 30<sup>th</sup> April, 2025 at 10:00 A.M** onwards. The online reporting time for interview will be communicated individually through Zoom link. The candidates shall adhere to the instructions and timings of joining the virtual interview. The candidate/s may be required to wait for the access as per the waiting list and the details of which will be communicated through email.
5. The candidates are advised to ensure good internet connectivity for the smooth conduct of the interview and download the relevant software (Zoom) to connect the link, IIMR doesn't take any responsibility if someone misses interview on these reasons

All the relevant original testimonials (date of birth, degree certificate, experience certificate, etc., if any) are to be shown and a set of attested copies of all the certificates will be required to be submitted by the candidates for verification, before joining, if selected.
